# Supervisors' Meeting

## January 4, 2016



Call to Order – Meeting was called to order at 7:20 pm by Chairman Morrow. In attendance were Supervisors Hunsinger, Bardo, Klinger and Carr.

<u>Approve December minutes</u> – On a Klinger/Carr motion, December minutes as presented were approved. Motion passed 5-0.

<u>Solicitor's Report</u>- Attorney Lewis spoke with Dennis Reedy, the developer for Sunland Preserve. He had questions and concerns regarding engineering fees in the developer's agreement along with some other issues. He was told to put it in writing and come to the February meeting with his questions.

<u>Police Report</u> – Reported by Chief VanDine. See attached. It was requested that Officer Sutton be advanced to Patrolman III as of January 1, 2016. On a Bardo/Klinger motion, advancement was approved. Motion passed 5-0. The Chief stated that the impound auction netted about \$9,500.00 Chief VanDine asked the board to consider hiring Garey Bittenbender as the police clerk with hours not to exceed thirty-two per week. On a Morrow/Bardo motion, authorization was given for Mr. Bittenbender to work part time as the police clerk. Motion passed 5-0.
